RULES AND REGULATIONS OF THE SOCIETY

NAME OF THE SOCIETY: ANIBISENT EDUCATIONAL SOCIETY (CHRYS ITY)

: The society consists of 11 Members. The Executive Bodyoner additional to the Executive Bodyoner and **MEMBERSHIP**

bers with the permission of the General Body (each member fee Rs.500/-)

FUNCTION OF SOCIETY: There shall be two bodies in the functioning of the society. 1. General body.2. Executive body.

GENERAL BODY

The annual General body meeting will be held in the month of March every year. The General body will elect the Executive body for every 5 years. The duties of the General body are to pass the budget for the ensuring year and to approve the expenditure of the previous year, to appoint an Auditor, to chalkout the programme for the development of the Society.

EXECUTIVE BODY

It consists of 11 Members i.e. 1. President 2. Vice President 3. Secretary 4. Joint Secretary 5. Treasurer and 6 other Members. The duties of the members will be finalised by the Executive body and they will meet thrice in a year. The life of the Executive body will be 5 years.

DUTIES OF THE EXECUTIVE BODY

PRESIDENT: He is the figure head of the Society and shall preside both the meetings of the General Body and Executive Body. He has got power to utilise his casting vote. The President shall be incharge of all receipts and shall be responsible for them for proper custody. He shall open Joint Account in any Nationalised Bank with the Secretary of the Society. It shall be the duty of the President to call the meetings of the Committee atleast once in every 4 months. It shall also be the duty of the President to call a meeting of the Committee within 15 days from the date of competent finalising from day the requisites specified the subsection (2) or the section 32 of the Act

VICE PRESIDENT: In the absence of the President, the duties of the president, will be performed by Vice President.

SECRETARY: The Secretary should call for the General Body meeting with the prior intimation of the President. He has to record the minutes of the meeting. He is responsible for the executive administration of the Society. The secretary shall be responsible for the General Body and administration of the Society. He is the Officer to use or be used of behalf of the Society shall be in his official designation. He is the correspondent of the educational institution under control of the Society. He has power on behalf of Society to supporting on Society, accounts identify with any other officers authorised for the purpose and subject to such restrictions and limits as laiddown by the General Body to buy, sale, pledge, endorse and transfer, promisory notes, Government and other securities standing in the name of the society to sign endorse and negotiate checks and other negotiable instruments and to sign all receipts and other documents connecting with the benefits of the Society.

JOINT SECRETARY: In the absence of the Secretary, the duties of the Secretary will be performed by

TREASURER: He has to receive the donations, subscriptions from the President / Secretary which

were collected from the Public and issue receipts for the said collections to the Secretary. He will prepare and present all accounts to the Auditor, General body

and the Executive Body.

MEMBERS: The Members will help to the above for the development of the society.

QUORUM

The Quorum for the general body as well as to the Executive body is 3/5th of the Members. **FUNDS**

The Funds shall be collected by way of subscriptions, contributions and donations etc., the money should be spent for achieving the objects of the society only. They should not be used for the personal needs of the individuals.

AMENDMENTS

Amendments to the objects and rules must be made in the General body with 3/5 the majority. Such amendments must be confirmed in the second special General body meeting intended for that purpose only be 3/5th members present and voting within one month from the first meeting.

LIQUIDATIONS

In case of the society has to be liquidated the properties of the society without liabilities should be liquidated in favour of another society having the same aims and objects. With the consent of the 3/5th the members of General Body.

FINANCIAL YEAR

The financial year of the society shall be 1st April to 31st March, of the nearest year.

ELECTIONS

The annual meetings of the General body shall be conducted in the month of March of every five years. The office bearers shall be elected at the time of celebration of annual meetings.
